ロンドンを対象として制定された地方法  
(Local Act) とその制定に関係した事務弁護士  
(Solicitor) と議会代理人 (Parliamentary Agent)

本資料は、ロンドン首都公文書館 (London Metropolitan Archives) に所蔵の首都公共事業庁 (Metropolitan Board of Works、以下MBW) およびロンドン県 (London County Council、以下LCC) が編纂した各年のロンドンに関する公法律・私法律法典 (Public and Private Act) のうち、1876年版から1913年版に掲載の地方法を、その制定に関係した事務弁護士または書記 (Town Clerk) および議会代理人の情報とともに整理したものであり、『法政理論』前号掲載資料<sup>1</sup>の続編である。

本資料について、まず、若干の説明を行いたい。第一に、前号では、表題で私法律という名称を使用していたが、今回は、以下の理由から地方法という用語を用いることとした。すなわち、それまで索引すらも十分に整備されていなかった広義の私法律について、その整理および法的効果残存の有無を精査する作業を1974年に国会から付託された法律委員会およびスコットランド法律委員会 (The Law Commission and The Scottish Law

Commission) は、1996年『制定法の整備-地方立法に関する年代順索引に関する報告書』<sup>2</sup>を国会に提出した。その中で、紆余曲折を経て1870年以降、広義の私法律のうち、各地方の公共的団体等への授権に関する法律は、地方法という名称で分類されてきたとしており、本稿では、この分類に従うこととしたためである。ただし、MBW、LCCが編纂した法典は、政府提案によって制定されたロンドンに関する公法律（Public Act）と公共的団体等が議会代理人を介して提案し国会が制定したロンドンに関する地方法から構成され、帰化など個人的事項に関する権限付与のための狭義の私法律が含まれていない一方で、その法典の名称は公法律・私法律法典とされていることから推測される通り、地方自治体レベルにおいては、慣習的に地方法を私法律と呼称していたと考えられる。

次に、MBWの法典編纂時期と今回の資料との関係についてである。MBWは、1855年にインナー・ロンドンの下水道を所管する複選制の地方団体として設置され、その後その所管機能を拡大させていった。この際に用いられた手法が地方法による権限付与であったことは、以前にも指摘したとおりである。ただし、MBWが公法律・私法律法典としての編纂を開始したのは、今回の資料で取り上げた1876年からのようである。というのは、ロンドン首都公文書館は、そもそもMBWを引き継いだLCCの公文書館であり、そこに所蔵されている法典が原典と考えられ、資料番号のvol.1が1876年から始まっているからである。したがって、1875年以前のロンドン関連の地方法が、法律ごとに所蔵されているか、もしくは別の形態の法典として纏められて保存されているかは今のところ不明であり、今後再度現地での資料調査を行う予定である。また、今回取り上げた期間で、欠落している版がある。この理由は、当該年度において、地方法が制

定されなかったという可能性も否定できないものの、別の資料<sup>3</sup>から、法律制定が行われていることは明らかである。想像の域を出ないが、現存の他の版の保存状態から推測するに、特に第二次世界大戦の際の空爆によって散逸したと考えられる。したがって、当該年度については、British Library等の資料で補足することを予定している。
