

〔資料紹介〕

20世紀初頭におけるロンドンを対象として 制定された私法律（Private Act）と その制定に関係した事務弁護士（Solicitor） および議会代理人（Parliamentary Agent）

本資料は、ロンドン首都公文書館（London Metropolitan Archives）所蔵の旧ロンドン県（London County Council）が編纂した各年のロンドンに関する公法律・私法律法典（Public and Private Act）のうち、1905、1906、1908年の3か年分の私法律を、関係した事務弁護士または書記（Town Clerk）および議会代理人の情報とともに整理したものである。ロンドンでは、1888年に首都公共事業庁（Metropolitan Board of Works）が発展的に解消する形で、都市問題に対応する総合行政主体である旧ロンドン県が設置されたが、他方当時のロンドンには、私法律によって特定目的のために個別に権限を付与された公共的団体（ad hoc body）が多数存在しており、1899年の改革でこれらの整理が図られたとはいえ300以上が残存し、そのおのおのの狭隘な所管範囲内で付与された単一権限を行使していたとされる¹。今回取り上げた時期はこの改革から10年目にあたり、本資料は総合行政主体設置後の私法律の制定状況を分析するための基礎資料

として意味を持つ。また、ここで取り上げた時期以外についても、時をおかずに紹介する予定である。

若干の考察

都市問題解決のために公権力を行使する特定目的団体の設置が「都市になる」ということであるとすれば、このための一つの重要な方策が私法律案 (Private Bill) の国会への請願であり、その成立に鍵となる役割を果たすのが、請願者と国会とをつなぐ議会代理人である²。前著³で指摘したとおり、この私法律をめぐる論点は、①都市問題解決と公権力付与および特定目的団体との関係、②個別法の一般法化と行政機能の拡大との関係、③社会の専門化と行政の専門化との関係、の3つに集約でき、このうち、本資料は、②および③の過程が進行・展開⁴した時期と重なる。

そこで、この2つの過程について、資料的制約があるものの、若干の考察を試みたい。まず、②について検討する。本資料の時期において、少なくともロンドンにおいて都市化という現象は、従前とは趣を異にした人口

の中心部から外縁部への移動へと変化を遂げており、それを促進した要因としては、いわゆるリボン・ディベロップメントと呼称される民間事業者による都市外縁部への鉄道の延伸と沿線での住宅開発があるとされる。本資料掲載の私法律の内容は、このような開発のために民間鉄道会社が多数の請願を行った事実を示している。他方で、都市問題解決に当たって必要となる公権力の付与という点から見れば、そのために新設の団体設置を請願する私法律は見られず、既存の自治体に対して都市開発権限を付与するための私法律が散見されるのみである。そこで、本資料からだけでは断定的な結論を導き出すことはできないが、19世紀末の改革によって、ロンドンにおいては、総合行政主体が設置され、一般法によって一定程度の権限が付与されると同時に、政省令により付加的な権限が付与されていった可能性が高い。その証左として、今回は紹介できなかったが、本資料に随伴して、かなりの命令確認法（order Confirmation Act）が発せられている事実がある。次の機会にはこれについて紹介したいと考えている。

次に、③についてであるが、本資料の私法律のほとんどすべてが、議会代理人の手のみならず、自治体が請願者の場合には書記の、民間事業者の場合には事務弁護士の手を経て国会に請願されている。前者の議会代理人については、請願を国会に提案できる資格は議会代理人にしかなく請願に当然必要とされる職である一方で、議会代理人の資格を持たない事務弁護士は必須ではない。それにもかかわらず、事務弁護士が請願に必要とされた理由は不分明である。そこで、少し視点を変えて、法案の請願者と事務弁護士等および議会代理人との関係に焦点を当ててみたい。まず、民間事業者が法案を提出する場合、制定される法律によって付与される権限等について法的観点から精査する必要があると考えられる。この役割を負うのが、当該民間事業者と顧問契約を結んでいる事務弁護士である。この事務弁護士が法案作成および議会審議対策の専門家である議会代理人と連携して法案成立に取り組んだのではなかろうか。他方、自治体においては、この事務弁護士の役割を書記が果たしていたと考えられる。この書記には法

律の素養が求められ、実際に事務弁護士の資格を持つものもいたことが本資料からも看取できる。さらに、同一自治体においては、同一人物が常にこの役割を果たしている。つまり、この時代において、すでに自治体においては人数は少ないにしても法律の専門知識を持つ職員が配置して私法律案作成ないしは精査に当たらせていた一方で、民間事業者においては、内部に法律職を抱えるのではなく、外部から事務弁護士を調達することで対応していたと考えられが、この両者にこのような相違が生まれた背景については不明である。ただし、少なくとも組織外部から専門家を招聘するという環境が整えられていたとみるべきであろう。

したがって、本資料より以前の私法律案に関する資料収集がこの仮説を立証する上で必要不可欠であるといえよう。
